## Introduction

---

This compendium is a companion to the [English Style Guide](#). For each EU Member State, plus certain other countries for which the relevant information is available, it provides English terms and translations. Most of the individual country sections contain a general introduction covering the country's name, official language(s) and parliament, followed by notes on geography, judicial bodies and legal instruments. For a number of countries there are additional notes on, for example, government bodies; administrative divisions; law gazettes, official gazettes and official journals. The tables provided show terms in the original language on the left and suggested English translations on the right. General guidance on the translation of geographical names, illustrated by specific examples, can also be found in the [English Style Guide](#).

The region tables are based on [NUTS](#) — the EU's *Nomenclature of Territorial Units for Statistics*. However, the NUTS regions, when referred to as such, are *not* translated. The translations should be used only in other contexts. In the tables, region levels 1, 2 and 3 are shown in bold, italic and plain font, respectively. Note that some countries have only level 2 or 3. Moreover, Cyprus and Luxembourg are not divided into regions for NUTS, so have no region sections.

# Austria

---

**Full name:** *Republic of Austria*. Note that the Austrian *Bundesländer* are called ‘provinces’ in English.

**Official language:** German.

**Parliament:** Austria has a bicameral parliament comprising the *Nationalrat* (lower house) and the *Bundesrat* (upper house). Where possible, use the German terms, with an explanation when first introduced, as indicated in Section 22.10 of the [English Style Guide](#). Alternatively, the official English translations may be used, provided that they are explained when first introduced, e.g. *National Council* (*Nationalrat*, i.e. the lower house of the Austrian Parliament) and *Federal Council* (*Bundesrat*, i.e. the upper house of the Austrian Parliament).

## Geography

### Cities

Write *Vienna* for *Wien*. Otherwise, retain the original spelling, including any accents (e.g. *Sankt Pölten*).

Be aware that, in texts written in languages other than German, names other than the German names may be used for places/provinces in Austria (e.g. *Graz* = Štýrský Hradec in Czech, Štajerský Hradec in Slovak, *Gradec* in Slovenian; *Klagenfurt* = Celovec in Slovenian; *Linz* = Linec in Czech/Slovak; *Villach* = Bělák in Czech, Beljak in Slovenian; *Burgenland* = Gradišće in Croatian, *Hradsko* in Czech [not to be confused with settlements of the same name in Czechia], *Gradiščanska* in Slovenian). Where an English equivalent does not exist (e.g. *Vienna*, *Styria*), always use the German names when writing in English.

### Lakes

Write *Lake Constance* for *Bodensee*.

### Mountains

Anglicise the *Alps*.

See also paragraphs 11.7 and 18.29 of the [English Style Guide](#). It is often simpler to reduce the naming of the parts as far as possible. So ‘§ 1 Abs. 2 Z 3’ may be translated as ‘§ 1(2), subparagraph 3’ (or as ‘Section 1(2), subparagraph 3’). If ‘Absatz 2’ and ‘Z 3’ are referred to in isolation, they may be translated as ‘paragraph (2)’ and ‘subparagraph 3’.

## Government bodies and administrative divisions

Bezirk	Translate as ‘district’ or ‘district authority’ [an Austrian <i>Bezirk</i> corresponds to a German <i>Kreis</i> in the <a href="#">NUTS</a> breakdown].
Bezirkshauptmann	Translate as ‘head of the district authority, District of ...’.
Bundesland, Bundesländer	<i>Bundesland/länder</i> are the usual terms in Austria and, for Austria, are translated as ‘province(s)’.
Bundesrat	Write ‘Bundesrat’. Where a gloss is considered necessary, add ‘the upper house of the Austrian Parliament’ in brackets after the first occurrence. Alternatively, the official English translation may be used, provided that it is explained when first introduced, e.g. ‘Federal Council (Bundesrat, i.e. the upper house of the Austrian Parliament)’.
Bundesversammlung	Translate as ‘Bundesversammlung’, adding ‘Federal Assembly’ in brackets after the first occurrence, if a gloss is considered necessary.
Gemeinde	Translate as ‘municipality’.
Land, Länder	See <i>Bundesland, Bundesländer</i> above.
Landeshauptmann	Translate as ‘Governor’.
Nationalrat	Write ‘Nationalrat’. Where a gloss is considered necessary, add ‘the lower house of the Austrian Parliament’ in brackets after the first occurrence. Alternatively, the official English translation may be used, provided that it is explained when first introduced, e.g. ‘National Council (Nationalrat, i.e. the lower house of the Austrian Parliament)’.

# Belgium

---

**Full name:** *Kingdom of Belgium.*

**Official languages:** Dutch, French and German.

**Parliament:** Belgium has a bicameral parliament. In English the *Chambre des Représentants/Kamer van volksvertegenwoordigers* should be referred to as *the lower house* or *the House of Representatives*, and the *Sénat/Senaat* should be referred to as the *upper house* or *the Senate*.

On special occasions the two houses sit jointly as the *Verenigde Kamers/Chambres Réunies (joint session of the Belgian Parliament)*.

## Geography

### Cities

Use the forms *Antwerp, Bruges, Brussels, Ghent, Ostend.*

**Flemish vs French forms.** Use Flemish names of places in Dutch-speaking areas (e.g. *Leuven* not *Louvain*, *Kortrijk* not *Courtrai*, *Ieper* not *Ypres*) and French for French-speaking areas (e.g. *Mons* not *Bergen*, *Liège* not *Luik*).

Bilingual *Bruxelles/Brussel* is always *Brussels* in English. Many of the 19 municipalities (FR *communes*, NL *gemeenten*) (and all streets) in the Brussels region have a French and a Dutch name, either of which may be used.

Some municipalities, known as *Communes à facilités/Faciliteitengemeenten/Gemeinden mit Spracherleichterungen*, have special linguistic provisions to protect the rights of their historic linguistic minorities.

In the Flemish Community this concerns six municipalities on the periphery of Brussels (*Drogenbos, Kraainem/Crainhem, Linkebeek, Sint-Genesius-Rode/Rhode-Saint-Genèse, Wemmel* and *Wezembeek-Oppem*) and six municipalities on the language border (*Bever/Biévène, Herstappe, Mesen/Messines, Ronse/Renaix, Spiere-Helkijn/Espierres-Helchin* and *Voeren/Fourons*).

In the French Community this also concerns six municipalities, four with special provisions for Dutch speakers (*Enghien/Edingen, Mouscron/Moeskroen, Comines-Warneton/Komen-Waasten* and *Flobecq/Vloesberg*) and two with special provisions for German speakers (*Malmedy* and *Waimes/Weismes*).

The nine municipalities that make up the German-speaking Community all have special language provisions for French speakers.

It should be noted that these municipalities do not have bilingual status. When writing in English, the French names should be used for those in the French Community, the

Flemish names for those in the Flemish Community and the German names for those in the German-speaking Community.

## Rivers

Use *Meuse* (*Maas* only if the context is solely Flanders or the Netherlands).

## Federal structure

Belgium is a federal kingdom made up of three *regions*:

- ♦ the *Flemish Region*  
(*het Vlaamse Gewest – la Région flamande – die Flämische Region*),
- ♦ the *Walloon Region*  
(*het Waalse Gewest – la Région wallonne – die Wallonische Region*), and
- ♦ *Brussels Capital Region*  
(*het Brussels Hoofdstedelijk Gewest – la Région de Bruxelles-Capitale – die Region Brüssel-Hauptstadt*)

and three *language communities*:

- ♦ the *Flemish Community*  
(*de Vlaamse Gemeenschap – la Communauté flamande – die Flämische Gemeinschaft*),
- ♦ the *French Community* (not French-speaking)  
(*de Franse Gemeenschap – la Communauté française* (since May 2011 also commonly known as *la Fédération Wallonie-Bruxelles*) – *die Französische Gemeinschaft*), and
- ♦ the *German-speaking Community* (not German)  
(*de Duitstalige Gemeenschap – la Communauté germanophone – die Deutschsprachige Gemeinschaft*).

The *Flemish Region* covers the north of the country down to a line running across the country just south of Brussels, but not including the *Brussels Capital Region* (which forms an enclave), while the *Walloon Region* covers the whole of the south of the country (including the German-speaking area). The regions may also be referred to

informally as *Flanders*, *Wallonia* and *the Brussels Region* (to distinguish it from *Ville de Bruxelles/Stad Brussel*, which is only one of 19 municipalities in the region).

The *Flemish Community* covers Flanders, plus Brussels (for Dutch-speaking cultural matters); the *French Community* covers Wallonia minus the German-speaking area, plus Brussels (for French-speaking cultural matters); and the *German-speaking Community* covers the small German-speaking part of the country. In May 2011, the parliament of the *French Community* voted to use the name *Fédération Wallonie-Bruxelles*. However, the new name does not appear in the Belgian Constitution and is not universally accepted.

The regions exercise powers in a wide range of areas, while the *communities* are primarily responsible for education and cultural matters. Under the Constitution each region and community has an executive accountable to a parliament. However, all the responsibilities of the Flemish Region have been transferred to the Community, so there is only one *Flemish Government* and one *Flemish Parliament*, both based in Brussels.

The executives of the other two regions are the *Walloon Government*, based in Namur, and the *Government of the Brussels Capital Region*. The leaders of all three executives wish to be described in English as *Minister-President*. Meanwhile, the French Community – based in Brussels and entirely separate from the Walloon Government in Namur – has handed over some of its responsibilities to the Region. The German-speaking Community, with its seat in Eupen, has fewer powers than the other two.

At federal level, the Belgian Government retains such pan-Belgian functions as foreign affairs, defence, justice, macroeconomic policy and the railways. In a Belgian context it may be referred to as the *Federal Government*.

## Brazil

---

**Full name:** Federative Republic of Brazil (*República Federativa do Brasil*)

**Official language:** Portuguese (many Amerindian languages and a few European languages are also spoken, but the only official language is Portuguese)

**Government type:** Federal presidential republic

**Legislative branch:** Bicameral - 513 seats in the Chamber of Deputies (Câmara dos deputados), 81 seats in the National Congress (Congresso Nacional)

**Executive branch:** The President is both Head of State and Head of Government. The Cabinet is appointed by the President.

**Judiciary:** Highest court – Supreme Federal Court (*Supremo Tribunal Federal*)

Other national courts include the Federal Court of Auditors (*Tribunal de Contas da União*), Superior Court of Justice (*Superior Tribunal de Justiça*), Superior Labour Court (*Tribunal Superior do Trabalho*) and Superior Electoral Court (*Tribunal Superior Eleitoral*). These are overseen by the National Justice Council (*Conselho Nacional de Justiça*).

Courts of first and second instance are at regional level.

## Geographical and administrative structure

Brazil is divided into **federative units** (*unidades federativas*): 26 **states** (*estados*) plus one **federal district** (*Distrito Federal*), the capital Brasília. Each state has its own executive, legislative and judiciary branches. There are 5 570 **municipalities**, each with its own local government comprising a mayor (*prefeito*) and a legislative body called the municipal chamber (*câmara municipal*). Another territorial subdivision is the **comarca** (no translation in English), which is a judicial district covering one or more municipalities.

The vast majority of the population live on, or in the vicinity of, the Atlantic coast: in cities from Porto Alegre (in the state of Rio Grande do Sul) in the far south to Fortaleza (in the state of Ceará) in the far north, via the huge population centres of São Paulo and Rio de Janeiro in the south-east. When writing Brazilian geographical names (cities, rivers, etc.) native spellings should always be used.



# Bulgaria

**Full name:** *Republic of Bulgaria.*

**Official language:** Bulgarian. For transliterating Bulgarian, see the table (Annex 2) in the [English Style Guide](#).

**Parliament:** Bulgaria has a unicameral parliament. Its full title, used in formal contexts, is *Narodno sabranie na Republika Bulgaria* (National Assembly of the Republic of Bulgaria). It is generally referred to as *Narodno sabranie*. This should be rendered in English as *the National Assembly (of Bulgaria)* or *(the Bulgarian) Parliament*.

## Geography

### Cities

Note the transliteration *Sofia* for the capital city. Avoid using forms such as *Rousse* and *Bourgas*, which, although French, are still sometimes found in English-language texts.

### § or section

The ‘§’-sign is used in final and transitional provisions instead of ‘член’. It stands for ‘параграф’. Translate it using the ‘§’-sign wherever possible to facilitate references to the original legislation. If this is not possible, use ‘section’.

### Option

To clarify what is meant by ‘option’, here is an example:

The investigation concerns several public officials suspected of having committed, between early 2009 and June 2011, offences under Article 282(2), first option, in conjunction with Article 282(1) and Article 20(2) of the Criminal Code (NK).

Article 282(2) NK reads as follows. Options 1 and 2 have been placed in square brackets:

Ако [от деянието са настъпили значителни вредни последици] или [е извършено от лице, което заема отговорно служебно положение], наказанието е лишаване от свобода от една до осем години, като съдът може да постанови и лишаване от правото по чл. 37, ал. 1, точка 6.

**Parliament:** The unicameral National People's Congress (NPC) (全国人民代表大会) has the power to legislate, to oversee the operations of the government, and to elect the major officers of state.

The NPC and the National Committee of the Chinese People's Political Consultative Conference (CPPCC) (中国人民政治协商会议全国委员会) — a political advisory body consisting of delegates from a range of political parties and organisations as well as independent members— are the main deliberative bodies of China, which make important national-level political decisions. The annual plenary sessions they convene are often referred to collectively as the Two Sessions (两会).

**Government:** The State Council (国务院), also called the Central People's Government (中央人民政府), is appointed by the National People's Congress and is the chief administrative authority of the People's Republic of China. It is chaired by the Premier and includes the heads of each government department and agency. The State Council directly oversees the various subordinate administrative divisions (local people's governments (地方政府), see table below).

**Official language:** Croatian.

**Parliament:** Croatia has a unicameral parliament known as the *Hrvatski sabor* or *Sabor*. It should be referred to in English as *the Croatian Parliament*.

Note that many Croatian place names exist in Italian, German, Hungarian and Slovenian. Unless an English name exists (e.g. *Dalmatia*, not *Dalmacija*), always use the Croatian name. # Cyprus

**Full name:** *Republic of Cyprus*. The long form may be used when contrasted with northern Cyprus, the ‘Turkish Republic of Northern Cyprus’. However, since the EU and its Member States do not recognise the latter and the Republic of Cyprus joined the EU on behalf of the whole island, ‘Cyprus’ is adequate for most purposes.

**Official languages:** Greek and Turkish (although the latter is not an EU official language). For transliterating Greek, see the table (Annex 1) in the [English Style Guide](#).

**Parliament:** Cyprus has a unicameral parliament known in Greek as the *Bouλή των Αντιπροσώπων* and in Turkish as the *Temsilciler Meclisi*. It should be referred to in English as *the House of Representatives*.

### Cities

For the capital, note *Nicosia* for *Λευκοσία (Levkosia)*.

### Regions

Cyprus constitutes a single level 2 [NUTS](#) region.

Full name: *Czech Republic*.

Official language: Czech.

**Parliament:** Czechia has a bicameral parliament. In Czech the full title of the lower house is *Poslanecká sněmovna Parlamentu České republiky*, often shortened to *Poslanecká sněmovna* and abbreviated as *PSP ČR* or *PS PČR*. In English it should be referred to as *the Chamber of Deputies of the Parliament of the Czech Republic* in formal contexts or, in less formal texts, as *the (Czech) Chamber of Deputies* or *the lower house of the Czech Parliament*. The full Czech title of the upper house is *Senát Parlamentu České republiky*, often shortened to just *Senát* or *Senát PČR*. In English it should be referred to as *the Senate of the Parliament of the Czech Republic* in formal contexts or, in less formal texts, as *the (Czech) Senate* or *the upper house of the Czech Parliament*.

## Geography

### Cities

Write *Prague* for *Praha*. Leave *Plzeň* in the Czech form (*Pilsen* is a style of beer). Be aware that German texts may use the German names for places in Czechia, referring to *Brno* as *Brünn* or *Karlovy Vary* as *Karlsbad*. Always use the Czech names when writing in English.

### Rivers

The river called the *Labe* in Czech is known as the *Elbe* in English. Write *Oder* for *Odra*.

**Full name:** *Kingdom of Denmark*. Neither Greenland (adjective: Greenland) nor the Faroe Islands (short form: Faroes; adjective: Faroese) are part of the European Union.

**Official language:** Danish.

**Parliament:** Denmark has a unicameral parliament known as *Folketinget*. It should be referred to in English as *Folketinget (the Danish Parliament)*.

Note the names *Copenhagen*, *Aarhus*, *Aalborg*.

### Bodies of water

Write *Wadden Sea* for *Vadehavet*. Use *Great Belt* for *Storebælt* and *Little Belt* for *Lillebælt*.

# Estonia

---

**Full name:** *Republic of Estonia.*

**Official language:** Estonian.

**Parliament:** Estonia has a unicameral parliament known as the *Riigikogu*. In English it should be referred to as *the Estonian Parliament* or *Parliament*, unless there is a particular reason to use the Estonian name.

The English-language names of the Committees, etc. can be found on the [Parliament](#) website.

## Geography

### Cities

Leave the names of urban centres, irrespective of size, in their original Estonian form, including diacritics (e.g. *Pärnu*, *Kohtla-Järve*, *Võru*, *Põlva*, etc.).

Be aware that historical names exist for some towns and are still used occasionally, but the Estonian names should always be used in English texts (e.g. write *Tallinn* (not the German *Reval*) and *Tartu* (not the German *Dorpat* or the Finnish *Tartto*)).

Note that *Valga* is in Estonia, while *Valka* is in Latvia.

### Counties

There are two ways of referring to counties in Estonian. The names may appear in the form *Harjumaa* / *Järvamaa* / *Lääne-Virumaa*, etc. or in the form *Harju maakond* / *Järva maakond* / *Lääne-Viru maakond*, etc. Use the former in English (e.g. *Harjumaa*, etc.), adding ‘the county of’ or ‘county’ where necessary for clarity (e.g. *the county of Harjumaa*, *Harjumaa county*, etc.).

### Islands

The islands of *Saaremaa* and *Hiiumaa* are both also counties in their own right, and so in some cases it may be necessary to write e.g. *the island of Saaremaa* to avoid confusion with the county of the same name.

Be aware that many of the islands also have historical names in Swedish, but the Estonian names should always be used in English texts (e.g. write *Saaremaa* (Swedish: *Ösel*), *Hiiumaa* (Swedish: *Dagö*), *Muhu* (Swedish: *Moon*), *Vormsi* (Swedish: *Ormsö*), *Kihnu* (Swedish: *Kynö*) and *Ruhnu* (Swedish: *Runö*)).

## Lakes and rivers

Write *Lake Peipus* for *Peipsi järv*, *Lake Võrtsjärv* for *Võrtsjärv* and *Lake Lämmijärv* for *Lämmijärv*. Write *the River Emajõgi*, *the Emajõgi River* or even just *the Emajõgi* (if the context is clear) for *Emajõgi*. For river names made up of two words (e.g. *Võhandu jõgi*), use either of the forms *the River Võhandu* or *the Võhandu River*.

## Government agencies and bodies

Government agencies and bodies are reorganised and renamed from time to time. The vast majority have English-language websites, and so these should always be checked for their official names. In most cases, it is sufficient to use just the English name without the Estonian, but if there is any chance of confusion it may be better to use the English name on the first occasion with the Estonian in brackets, and then the English name on subsequent occasions. One exception to this is *Eesti Pank*, which should not be translated. On first mention in a text, write *Eesti Pank (Bank of Estonia)*, but afterwards write just *Eesti Pank*.

Names may be abbreviated if they are commonly abbreviated in Estonian and if a suitable English abbreviation exists, for example on the body's website. *Põllumajanduse Registrite ja Informatsiooni Amet* is often abbreviated in Estonian to

PRIA, and its website uses both the full name *the Estonian Agricultural Registers and Information Board* and the abbreviation *ARIB*. The same applies to *Keskonnainvesteeringute Keskus (KIK) / the Environmental Investment Centre (EIC)*. The *Police and Border Guard Board* is less frequently abbreviated to *PBGB*. However, only abbreviate where this helps the reader. If there is no risk of confusion, it might be better to write *the Board* (rather than *ARIB* or *PBGB*) or *the Centre* (rather than *EIC*), etc., having written the name out in full on first mention.

*Riigi Teataja* is the sole official publication for the types of legal act referred to in Section 2 of the *Riigi Teataja* Act (available in [Estonian](#) and [English](#)), including Acts of Parliament, decrees issued by the President of the Republic, regulations issued by the Government of the Republic, international agreements and many others. Since 2010 it has been published in electronic form only.

*Ametlikud Teadaanded* is an electronic journal containing all notices, invitations and announcements that have to be published by law. They are not available in English.

In English texts the names *Riigi Teataja* and *Ametlikud Teadaanded* should be left in Estonian, although the English translation should usually be added in brackets after the first mention of each name in a text. In references, *Riigi Teataja* is abbreviated to *RT*.

# Finland

**Full name:** *Republic of Finland*. Call the country's main administrative/regional units (*lääni*) 'provinces' in English.

**Official languages:** Finnish and Swedish

**Parliament:** Finland has a unicameral parliament known as the *Eduskunta* in Finnish and *Riksdagen* in Swedish. It should be referred to in English as *the Parliament of Finland* or *the Finnish Parliament*.

## Geography

### Cities

Finland is a bilingual country, and many cities and localities have official names in both Finnish and Swedish. When translating from either language, remember that the form to be used depends on the local language situation, not on the text you are translating. Note in particular that for all major cities the Finnish name must be used: write *Helsinki*, *Oulu*, *Tampere*, *Turku*, not *Helsingfors*, *Uleåborg*, *Tammerfors*, *Åbo*. For other place names, see the [list of Swedish place names and their Finnish equivalents](#) (shown in orange) kept by the Research Institute for the Languages of Finland. If no Finnish name is given, the Swedish name should be kept. If you need to translate Finnish place names into Swedish, use the bolded form in blue in the [list of Finnish place names and their Swedish equivalents](#).

# France

---

**Full name:** French Republic. *La France métropolitaine* (which comprises mainland France and nearby French islands — the 96 European departments) is *metropolitan France* in English. *Les départements d'outre-mer* (DOM) are the (French) overseas departments. Do not abbreviate. *Les pays et territoires d'outre-mer* (PTOM) are the *overseas countries and territories* (OCTs).

**Official language:** French.

**Parliament:** France has a bicameral parliament. In English the *Assemblée nationale* should be referred to as *the lower house* or *the National Assembly*, and the *Sénat* should be referred to as *the upper house* or *the Senate*.

### Cities

Write *Lyon*, *Marseille*, *Strasbourg*.

### Rivers and lakes

Use the forms *Meuse* (*Maas* only if the context is solely Flanders or the Netherlands) and *Moselle* (*Mosel* only if the context is solely Germany). Write *Rhine* for *Rhin*. Use *Lake Geneva* for *Lac Léman*.

### Islands

Write *Corsica*.

### Mountains

Anglicise the *Alps*, and *Pyrenees* (no accents). Do not anglicise *Massif Central* (except for capital C) and *Alpes Maritimes* (capital M).

### Regions

The French regions were reorganised with effect from 1 January 2016. The number of regions was reduced from 21 to 12.

# Germany

---

**Full name:** *Federal Republic of Germany*. The full name is no longer obligatory in all contexts, as was the case before unification.

**Official language:** German.

**Parliament:** Germany has a bicameral parliament comprising the *Bundestag* (lower house) and the *Bundesrat* (upper house). Where possible, use the German terms, with an explanation when first introduced, as indicated in Section 22.10 of the [English Style Guide](#).

## Geography

### Cities

Use the forms *Cologne*, *Munich* and *Nuremberg*. Otherwise, retain the original spelling, including any accents (e.g. *Düsseldorf*).

Be aware that, in texts written in languages other than German, names other than the German names may be used for places in Germany (e.g. *Aachen* = *Cáchy* in Czech/Slovak, *Aix-la-Chapelle* in French, *Aquisgrana* in Italian, *Akwizgran* in Polish; *Konstanz* = *Kostnica* in Czech, *Konstancja* in Polish, *Kostnica* in Slovak; *Leipzig* = *Lipsko* in Czech/Slovak, *Lipcse* in Hungarian, *Lipsk* in Polish [not to be confused with the towns of *Lipsko* and *Lipsk* in Poland]; *Mainz* = *Mohuč* in Czech/Slovak, *Moguncja* in Polish; *Potsdam* = *Postupim* in Czech/Slovak; *Rügen* = *Rugia* in Polish; *Usedom* = *Uznam* in Polish). Where an English equivalent (e.g. *Cologne*, *Munich*) does not exist, always use the German names when writing in English.

### Rivers, lakes and other bodies of water

Use *Mosel* only if the context is solely Germany, otherwise use *Moselle*. Write *Rhine* for *Rhein*. Use *Lake Constance* for *Bodensee* and write *Wattenmeer*.

### Mountains

Anglicise the *Alps*. Do not anglicise *Schwäbische Alb*.

Full name: *Hellenic Republic*.

Official language: Greek. For transliterating Greek, see the table (Annex 1) in the [English Style Guide](#).

Parliament: Greece has a unicameral parliament known as the *Bouλή των Ελλήνων*. It should be referred to in English as *the Hellenic Parliament*.

## Geography

### Cities

Use traditional English spellings for well-known cities, regions, islands, etc. — the officially recommended transcription system has not found acceptance even within the European Union and is unknown elsewhere. However, use transliteration for unfamiliar localities, and note that preference should always be given to the demotic forms of place names (where known).

Anglicise the *Pindus Mountains*.

Official language: Hungarian.

**Parliament:** Hungary has a unicameral parliament known as the *Országgyűlés*. It should be referred to in English as *the National Assembly (of Hungary)* or *the (Hungarian) Parliament*.

Always use the Hungarian names of cities (retaining any accents) when writing in English.

# Iceland

---

**Full name:** *Iceland*. Although Iceland is a republic and is sometimes referred to as the *Republic of Iceland*, the official name of the country is simply *Iceland*.

**Official language:** Icelandic.

**Parliament:** Iceland has a unicameral parliament called *Alþingi* in Icelandic. The English-language website of Alþingi is not consistent on how this should be anglicised (using both *Althingi* and *Althing*). Use *Althingi*, as this reflects pronunciation in modern Icelandic. Alternatively, write *the Icelandic Parliament* (also used on the Althingi website).

Althingi is headed by a *Speaker* and *Deputy Speakers*.

## Geography

### Cities and towns

Write *Reykjavik* (without diacritic) for *Reykjavík*, Iceland's only city. All other inhabited areas are towns or villages, and should be written with all diacritics and special characters, e.g. *Egilsstaðir*, *Hafnarfjörður*.

Reykjavik and six neighbouring municipalities (Garðabær, Hafnarfjörður, Kjósarhreppur, Kópavogur, Mosfellsbær and Seltjarnarnes) form an area known in Icelandic as *Höfuðborgarsvæðið*. Write *Greater Reykjavik* (preferred) or *the Capital Region* (literal translation).

### Lakes, mountains, volcanoes, glaciers, national parks

All Icelandic lakes, mountains, volcanoes and glaciers should be written with all diacritics and special characters, e.g. *Markarfljót*, *Bárðarbunga*, *Eyjafjallajökull*.

Iceland's three national parks should be written in English as follows:

## Ireland

---

**Full name:** *Ireland*. Ireland is the full name laid down in the Irish Constitution; *Éire* (the name in Irish) and *Republic of Ireland/Irish Republic* are incorrect in English.

**Official languages:** English and Irish. Note that Irish became an EU official language on 1 January 2007, but there is a derogation (reviewable on a five-yearly basis) limiting what must be translated into Irish — see [Council Regulation \(EC\) No 920/2005](#) for details.

Irish should not be referred to as ‘Gaelic’; the terms are not synonymous because Gaelic can also mean Scots Gaelic.

**Parliament:** Ireland has a bicameral parliament. The Irish Parliament or *Oireachtas* is made up of *the President*, *Dáil Éireann* (lower house) and *Seanad Éireann* (upper house). *Dáil Éireann* and *Seanad Éireann* are the official names in English as well as Irish. In less formal contexts, the shorter forms *the Dáil* and *the Seanad* may also be used.

## Geography

The term *Britain and Ireland*, rather than *the British Isles*, is used in the geographical sense of Britain, Ireland and the surrounding islands. *The island of Ireland* is very widely used to refer to the whole of Ireland as opposed to the state of Ireland.

### Place names

Use the English names of cities, towns, other settlements and geographical features except if they are located in Irish-speaking ([Gaeltacht](#)) areas, in which case the official Irish-language versions of place names should be used, followed by the English names in brackets where necessary to aid comprehension. However, use both names (separated by a forward slash) for *Dingle/Daingean Uí Chuíis*.

The official Irish-language versions of place names are set out in Placenames Orders that implement the Official Languages Act 2003 (for the Irish-speaking areas, these are the [Placenames \(Ceantair Ghaeltachta\) Order 2004](#) and the [Placenames \(Ceantair Ghaeltachta\) Order 2011](#)).

A full list of English and Irish names can be found in the [Placenames Database of Ireland](#). Entries for places which are located in the Gaeltacht include the note ‘This is in the Gaeltacht’ under the ‘Properties’ heading. If possible, consult an Irish-speaker in order to determine correct usage in case of doubt.

# Italy

---

Full name: *Italian Republic*.

Official language: Italian.

**Parliament:** Italy has a bicameral parliament, consisting of *the Chamber of Deputies* (*Camera dei Deputati*), which is directly elected, and *the Senate* (*Senato*), whose members are directly elected on a regional basis, plus a few life members. Particularly in the Italian press, the two parliamentary houses are often referred to by the names of their respective buildings: the Chamber of Deputies as (*Palazzo*) *Montecitorio* and the Senate as *Palazzo Madama*. *Palazzo Chigi* is used for the Prime Minister and *Farnesina* for the Ministry of Foreign Affairs. In English, the names of the buildings are not used and are replaced by the institutions they stand for.

## Geography

### Cities

Use the English spellings *Florence*, *Genoa*, *Milan*, *Naples*, *Rome*, *Turin*, *Venice*. Take care not to use the French spelling of other towns, which may differ only slightly from the Italian.

### Rivers and lakes

Write *Tiber* for *Tevere* and *Lake Maggiore* for *Lago Maggiore*.

### Islands

Use *Sicily* and *Sardinia*.

### Mountains

Anglicise the *Alps*, *Apennines* (one *p*) and *Dolomites*.

In English, this should be rendered as *the Seimas* (followed by the words *Lithuanian Parliament* in brackets after the first occurrence, if necessary to aid comprehension) or as *the Lithuanian Parliament* (followed by the word *Seimas* in brackets after the first occurrence).

### Cities

Note that *Memel* (German) is *Klaipėda* in Lithuanian.

Use the forms *Curonian Lagoon* for *Kuršių marios* and *Curonian Spit* for *Kuršių nerija*.

## Law gazettes, official gazettes and official journals

*Valstybės žinios* (Official Gazette) is the sole official publication for primary and secondary legislation. It contains, *inter alia*, laws, international agreements, other legal acts passed by the Lithuanian Parliament, presidential decrees, government resolutions, decisions, resolutions and conclusions of the Constitutional Court, and orders and other normative legal acts of ministers, heads of government bodies and heads of other state authorities.

*Informacinių pranešimai* (Information Notices) is published as a supplement to *Valstybės žinios* and contains, *inter alia*, public procurement notices (calls for tender), information on public auctions, information notices issued by ministries, government institutions and other state governing institutions, and information notices issued by the Lithuanian Parliament.

When *Valstybės žinios* (or the abbreviated form *Žin.*) appears for the first time in a text, refer to it as ‘*Valstybės žinios* (Official Gazette)’ (or ‘*Žin.* (Official Gazette)’). If it appears again, refer to it as ‘*Valstybės žinios*’ (or ‘*Žin.*’).

When *Informacinių pranešimai* appears for the first time in a text, refer to it as ‘*Informacinių pranešimai* (Information Notices)’; if it appears again, refer to it as ‘*Informacinių pranešimai*’.

References to *Valstybės žinios* should be presented as follows: ‘*Valstybės žinios* 1997, No 614-1500; 1998, Nos 109-2996 and 114-3189; 2000, No 32-889’ or ‘*Žin.* 1997, No 614-1500; 1998, Nos 109-2996 and 114-3189; 2000, No 32-889’, inserting ‘(Official Gazette)’ where appropriate.



# Luxembourg

---

**Full name:** *Grand Duchy of Luxembourg*. Note the spelling, and use it for the capital city as well. Note *Luxembourg Government*, *Luxembourg cuisine*, *the Luxembourg climate*, but when referring to the language use the *-ish* form: *Luxembourgish expressions*, *Luxembourgish poetry*. Where French texts refer simply to *le Grand-Duché*, render in English as *Luxembourg*.

**Official languages:** French, German and Luxembourgish (although the latter is not an EU official language).

The [Act of 24 February 1984 on the language regime](#) states that the national language is Luxembourgish, the legislative language is French and the administrative languages are French, German and Luxembourgish.

**Parliament:** Luxembourg has a unicameral parliament known as the *Chambre des Députés*. It should be referred to in English as *the Parliament*.

### Rivers

Use *Moselle* (*Mosel* only if the context is solely Germany).

### Regions

Luxembourg constitutes a single [NUTS](#) region.

# Netherlands

---

**Full name:** *Kingdom of the Netherlands (Koninkrijk der Nederlanden)*. Holland is only part of the Netherlands (the provinces North and South Holland). The adjective is *Dutch*: the Dutch Government, the Dutch delegation, Dutch industry, etc., notwithstanding certain proper names such as the former Netherlands Antilles, which was dissolved on 10 October 2010; Curaçao and Sint Maarten (now *aparte landen* [constituent countries] within the Kingdom of the Netherlands, like Aruba) have retained the Netherlands Antillean guilder (ANG) pending the possible creation of a common currency (the Caribbean guilder). The other Antillean islands of Bonaire, St Eustatius and Saba are now *bijzondere gemeenten* [special municipalities] of the Netherlands (or *Caribisch Nederland*) and use the US dollar as their currency.

**Official language:** Dutch.

**Parliament:** The Netherlands has a bicameral parliament.

The *Staten-Generaal* comprises the *Eerste Kamer* and the *Tweede Kamer*; the official Dutch Government translations are *Dutch Parliament*, *Senate* and *House of Representatives* respectively. However, *Eerste Kamer* and *Tweede Kamer* can also simply be translated as *upper house* and *lower house*. Alternatively, use the Dutch terms with a gloss in brackets: *the Staten-Generaal (Dutch Parliament)*, *the Eerste Kamer (upper house of the Dutch Parliament)*, *the Tweede Kamer (lower house of the Dutch Parliament)*.

On special occasions the two houses sit jointly as the *Verenigde Vergadering* (*joint session of the Dutch Parliament*).

If any of these terms occur repeatedly in a text, the Dutch name may be used, with the English translation between brackets the first time the term is introduced.

## Geography

### Cities

Always write *The Hague* with a capital T except when used attributively (e.g. *the Hague Convention*).

### Rivers and other bodies of water

Use *Maas* only if the context is solely the Netherlands or Flanders, otherwise use *Meuse*. Write *Rhine* for *Rijn*. Write *IJsselmeer* (not *Ij-* or *Y-*).

### Islands

Use *West Frisian Islands* for *Waddeneilanden*.

# Poland

---

Full name: *Republic of Poland*.

Official language: Polish.

Parliament: Poland has a bicameral parliament.

The lower house is in most contexts referred to as the *Sejm*. In English, this should be rendered as *the Sejm* (followed by *lower house of the Polish Parliament* in brackets after the first occurrence, if necessary to aid comprehension). The full Polish title, as used in certain formal contexts, is *Sejm Rzeczypospolitej Polskiej* (*Sejm of the Republic of Poland*).

The upper house is in most contexts referred to as the *Senat*. In English, this should be rendered as *the Senate* (followed by *upper house of the Polish Parliament* in brackets after the first occurrence, if necessary to aid comprehension) or *the Polish Senate*. The full Polish title, as used in certain formal contexts, is *Senat Rzeczypospolitej Polskiej* (*Senate of the Republic of Poland*).

The Sejm and Senate combine for certain purposes to sit as *the National Assembly* (*Zgromadzenie Narodowe*).

## Geography

### Cities

Write *Warsaw* for *Warszawa*, but use the native forms in all other cases, including *Kraków* (rather than *Cracow*).

Be aware that German names exist for many towns and cities in Poland and are commonly found in German texts: always use the Polish names when writing in English (e.g. use *Gdańsk* (German: *Danzig*), *Kraków* (German: *Krakau*), *Wrocław* (German: *Breslau*), *Szczecin* (German: *Stettin*), *Świnoujście* (German: *Swinemünde*), and *Poznań* (German: *Posen*)).

### Provinces

**Full name:** *Russian Federation*

**Official language:** Russian<sup>1</sup>

**Parliament:** State power is exercised by the President of the Russian Federation, the Prime Minister, the bicameral Federal Assembly (*Федеральное собрание*), and the Constitutional Courts.

The Federal Assembly is a permanent working body, comprising two chambers: the State Duma (*Государственная дума*, abbreviated as *Госдума*) and the Federation Council (*Совет Федерации*). The State Duma is the lower chamber; it passes laws which are later confirmed by the Federation Council.

<sup>1</sup> Whilst Russian is the official language of the government administration, 14 languages have official status: Chukchi, Dolgan, Even, Evenki, Finnish, Kazakh, Karelian, Khanty, Komi-Permyak, Mansi, Nenets, Selkup, Veps, and Yukaghir. In addition, republics of the Russian Federation with a ‘titular nationality’ can also choose their own official language besides Russian (e.g. Tatar in the Tatarstan Republic). There are 30 languages that are official only in certain parts of Russia. Under its constitution, the Russian Federation guarantees all of its nations the right to preserve their native language, providing conditions for its study and development.

## Rivers

Write *the (River) Dnieper* for *Днепр*, *the (River) Neva* for *Нева*, *the Northern Dvina* for *Северная Двина*, *the Western Dvina* for *Западная Двина*. Note that the river which flows through Moscow is the Moskva River (*Москва-река*).

## Regions

*Oblasts, republics, krais, autonomous okrugs, autonomous oblasts and cities of federal importance* are constituent entities or federal subjects of the Russian Federation (*субъект Российской Федерации*). Russia is divided into 83 federal subjects and two cities of federal importance (Moscow and St Petersburg).

Republics can be considered politically autonomous as they have their own legislature and their own constitution. The federal government acts as the foreign policy mediator for the republics.

Note that *область* can also be translated as *region*, *округ* as *district* and *край* as *territory*.

## Federal Subjects

Under the Russian Federal Constitutional Law signed by President Putin in March 2014, the Republic of Crimea joined the Russian Federation, establishing two new constituent entities: the *Autonomous Republic of Crimea* (*Республика Крым*) and the *City of Sevastopol* (*Город Севастополь*). The EU does not recognise these entities as a part of the Russian Federation, hence they are not included in the list below.

Russia is divided into eight federal districts (*федеральные округа*) which are not federal subjects but groupings of them. Each of them has a presidential envoy (*Полномочный представитель Президента Российской Федерации в федеральном округе*) who reports directly to the President. In March 2014, the *Crimean Federal District* (*Крымский федеральный округ*) was declared to be part of the Russian Federation; it is not recognised by the EU and thus it is not included in the list below.

# Slovakia

Full name: *Slovak Republic*.

Official language: Slovak.

Adjective: Slovak.

**Parliament:** Slovakia has a unicameral parliament. In Slovak its full title is *Národná rada Slovenskej republiky*, often shortened to *Národná rada* and abbreviated as *NR SR*. In English it should be referred to as *the National Council of the Slovak Republic* in formal contexts or, in less formal texts, as *the (Slovak) National Council* or just *the Slovak Parliament*.

## Geography

### Cities

Be aware that Hungarian texts will nearly always use the Hungarian names for places in Slovakia, referring to *Bratislava* as *Pozsony*, *Trnava* as *Nagyszombat* or *Košice* as *Kassa*. Similarly, German texts may use the German names, referring to *Bratislava* as *Pressburg*, *Trnava* as *Tyrnau* or *Košice* as *Kaschau*. Always use the Slovak names when writing in English.

# Slovenia

Full name: *Republic of Slovenia*.

Official language: Slovenian.

**Parliament:** Slovenia has a bicameral parliament. The Slovenian Parliament (*Slovenski parlament*) consists of the *Državni zbor* and the *Državni svet*. These should be referred to in English as *the National Assembly* and *the National Council*. Insert *lower house of the Slovenian Parliament* and *upper house of the Slovenian Parliament*, respectively, in brackets after the first occurrence, if necessary to aid comprehension.

## Geography

### Cities

Be aware that German texts may refer to *Ljubljana* as *Laibach* and that Italian texts may refer to *Koper* as *Capodistria*. Always use the Slovenian names when writing in English. In the case of town names whose second word has an initial small letter in Slovenian, use an initial capital (e.g. for *Novo mesto* write *Novo Mesto*).

# Spain

---

**Full name:** *Kingdom of Spain*. The 17 political/administrative units into which Spain is divided are called *Autonomous Communities* in English. Translate *Presidente del Gobierno* as *Prime Minister (of Spain)*.

**Official language:** Spanish. The regional languages Catalan, Galician and Basque are also recognised at EU level, in that Spanish citizens can communicate with the EU institutions in these languages.

**Parliament:** Spain has a bicameral parliament. Its generic name is *las Cortes Generales* and it is divided into the *Congreso de los Diputados* (the lower house) and the *Senado* (the upper house). These should be referred to in English as *the Spanish Parliament, the Congress of Deputies and the Senate* respectively.

Each autonomous community has its own single-chamber parliamentary assembly. These should be referred to as *the Catalan Parliament, the Basque Parliament*, etc.

The names of the governments of the autonomous communities should be translated as follows: ‘Government of the Autonomous Community of ...’, thereafter ‘the ..... Government’, giving the title in the original language, in brackets and italics, the first time it appears (e.g. ‘Government of the Autonomous Community of Cantabria (*Gobierno de Cantabria*)’, thereafter ‘the Cantabrian Government’).

**Parliament:** Sweden has a unicameral parliament known as the *Riksdag*. The name is left untranslated, as *the Swedish Riksdag* or simply *the Riksdag*. *Kammaren* is translated simply as *the Chamber*.

Parliament: the Federal Assembly (*Assemblée nationale / Bundesversammlung / Assemblea federale*), which meets in Berne and has two houses; the upper house is the Council of States (*Conseil des États / Ständerat / Consiglio degli Stati*) and the lower house is the National Council (*Conseil national / Nationalrat / Consiglio nazionale*). It should be referred to in English as *the Parliament*.

Member of EFTA, but not the EEA.

## Geography

### Cities

Use the forms *Basel*, *Berne*, *Geneva* and *Lucerne*. Otherwise, retain the native form in official use in the canton concerned (e.g. *Zürich* rather than *Zurigo*, *Neuchâtel* rather than *Neuenburg*).

No city in Switzerland has the official status either of capital or of federal city; nevertheless Berne, the seat of the federal authorities, is commonly referred to as ‘Federal City’.

### Rivers and lakes

Write *Rhine* for *Rhein*, *Lake Constance* for *Bodensee*, *Lake Geneva* for *Lac Léman* and *Lake Lucerne* for *Vierwaldstättersee / Lac des Quatre Cantons / Lago dei Quattro Cantoni*.

Anglicise the *Alps* and the *Bernese Oberland*.

# United Kingdom

**Full name:** *United Kingdom of Great Britain and Northern Ireland*. Avoid the colloquial *Britain* and *British* in legal or formal texts. Use GB only for the international vehicle identification. Note that the abbreviation 'RU' is sometimes used in French texts for 'UK', but it might also mean Russia.

**Official language:** English.

**Parliament:** The United Kingdom has a bicameral parliament comprising *the House of Commons* (the lower house) and *the House of Lords* (the upper house). It also has three devolved legislatures: *the Northern Ireland Assembly*, *the Scottish Parliament* and *the National Assembly for Wales*.

## Geography

*Great Britain* comprises England, the Principality of Wales and Scotland; these three together with Northern Ireland form the *United Kingdom*. Never use *Ulster* for the province of Northern Ireland: Ulster includes the Irish Counties of Cavan, Donegal and Monaghan *plus* Northern Ireland. The term *the British Isles* is a geographical designation covering the territories of Ireland and the United Kingdom, plus the Isle of Man and the Channel Islands. In recent years, however, it has been replaced in official pronouncements by *Britain and Ireland*.
